All jobs are guaranteed for one year unless otherwise specified.

The above work to be performed as specifications submitted and completed in a substantial workmanlike manner.

Payments to be made in US dollars in full upon completion of the job.

A fee of 1.8% interest compounded monthly will be applied to all past due invoices. Any alteration or deviation from above specifications involving extra charges will be executed only upon written orders, and will become a written charge over and above the estimate. (Workmen's Compensation and public insurance on above work to be taken out by DJ's Painting, Inc.) Lead testing will be done on all jobs. If lead is detected, the customer will be responsible for all clean-up costs associated with lead contamination as well as all related expenses incurred by DJ's Painting.

We may withdraw this proposal if not accepted in 30 days. Upon clicking/accepting/signing the attached proposal prices, specifications and conditions are satisfactory and are hereby accepted. You have authorized DJ's Painting, Inc. to do the work as specified. Payment will be made as outlined above. In the event that payment is not made as outlined above, the undersigned agrees to pay for all interest, late and legal fees over and above the estimate. You may cancel this contract anytime before midnight of the 3rd business day after signing a copy of this contract. To cancel this contract, you must send a written notice of cancellation via certified mail or in person to: DJ's Painting 168 Richards Road, Bridgeton, NJ 08302. DJ's Painting, Inc. reserves the right to file a notice of intention to file a mechanics lien with respect to the project for the work to be performed.

Phase Dilation & Delay

In the event that a project, or phase thereof, shall become unduly delayed by the inaction or nonpayment of the owner/agent then DJ's Painting Local, Inc. shall have the right to cease all activity until payment is tendered in full for the project. If any project or phase is delayed for a period of longer than five (5) days, then DJ's Painting Local, Inc. shall have the right to terminate its obligations under this contract, and owner/agent shall hold the company harmless for any and all liabilities as may arise from incomplete work and from any additional expense that owner/agent incurs in having the work completed/altered/removed by another party. If the undue delay causes the project to become more expensive or more difficult to accomplish then DJ's Painting Local, Inc. shall have the right to terminate this contract upon written notice, or to demand payment sufficient to compensate the company for the increase in difficulty or expense.

For Clients with Aluminum Siding

Our coatings are only as good as the surfaces to which they are applied. We cannot be held responsible for coating failure when the cause is the coating previously existing on the siding before we arrive. The darker the color selected for your aluminum siding, the more the coating will expand and contract, putting underlying coatings at higher risk of failure. The only solution to 100% mitigate these potential issues is to fully strip the siding before we complete the painting. If there is a coating failure and the back of the failing chip / bubble is not the color we applied, the failure is not our work and will not be warrantied.
